## ABOUT OUR JUDGE TRACEY FLETCHER (NAPIER)

With my husband Michael I have actively been involved breeding and showing Bull Terriers since the early 1980's. During this time I have sat on various regional Bull Terrier Committees, including The Bull Terrier Club, Coloured Bull Terrier Club and Bull Terrier Club of Wales I am currently BTC Welfare Trust Coordinator and have previously for many years served as Chairperson of BTC Welfare Trust.

My husband's family had always had Bull Terriers so when we bought our first house it was a natural progression for us to get our first Bull Terrier. Our 3rd Bull Terrier bitch we owned was our foundation bitch Snowy, "Merlindan Snowbunting at Napier" (CH Merlindan Snowbird x CH Maximillion Bully Boy of Jobrulu)

We mated Snowy to CH Mapalee Inoxydale, she had 3 promising puppies that we showed and did quite well with. Jim, Napier Quixotic. Tia, Napier Quintessential of Willeve. Bonny, Napier Quid Pro Quo. Tia mated to Jamie's Bright Star at Ishaba. produced "Tilly" Willeve's Ruby Red Dancer at Napier. Although we didn't show Tilly she was bred her to CH Flashpoint Inferno at Kilacabar. And from that mating we had our first UK Champion. CH Napier Jenny Wren. "Jenny" she was well campaigned around the country winning at The Bull Terrier Club Trophy's The Regent Trophy plus the Claret Jug for Top Breeders 1999.

We mated "Jenny" to Cwmdulias Flash Harry giving us "Ginny" Napier Eye Candy aka Ginny The Pie Girl. A really beautiful bull terrier so big and powerful but still feminine. we were so pleased with her we repeated the mating and this produced "Taylor" Multi CH Napier Taylor May. who went to live in Italy and became a Multi Champion in many European countries as far afield as Croatian getting her Champion titles.

As nice as the pie girl was, she didn't like showing, she went to a couple of shows wining a reserve CC at Blackpool Championship show. We mated her to a nice red dog on his holidays from American at Dazlin Bull Terriers. "Floyd" CH Skyline Defies Dazlin. Ginny gave us 2 bitch puppies. These two puppies were beautiful one white and one red and both made Champions. 'Candy" CH Napier Mary Jane & 'Ruby" CH Napier Rosella. Both were winners at The Bull Terrier Club Trophies, Ruby winning the Sandawana Trophy for top coloured and runner-up in The Ormandy Jug for Bitches. Candy won The Ormandy Jug and was runner up and Best Opposite Sex in The Regent Trophy.

Both Candy & Ruby were picked for the Dutch International Country Competition Ruby twice & Candy once and each time both were successful in winning the over 2 years class and being members of the overall winning teams.

We have had successes with other Bull Terriers from Best of Breed at Crufts to importing the first Bull Terrier to become a British Champion under the pet passport scheme "Dave" Multi Champion Grisse Basse Charming White Devil. who was a Champion from Holland and a Champion in many European and Nordic countries. After gaining his Champion title he went back home to Holland.

We owned and showed Miniature Bull Terriers over 30 years ago in the 1980's and have moved back into Miniature Bull Terriers in the last few years, importing and gaining his British Champion status "CoCo" Multi Champion Canabull North Wind. Plus gaining the title "Top winning Miniature 2017" We also campaigned his sister to her Championship on behalf of her breeders.

Napier Bull Terriers have had great successes with dogs we have bred and exported, exporting to many countries around the world & many gaining Champion status in Europe, America and South Africa.

I would like to thank the West of England BTC for this invitation to judge their Championship Show and being my first Championship appointment will always make this a very special day for me.

## **RULES AND REGULATIONS**

- 1` The Show will open at 10.00 am.
- 2 Dogs will be received at anytime but it is the exhibitor's responsibility to ensure that dogs are available for judging when required.
- 3 Judging will commence at 10.30 am.
- 4 Exhibits may be removed from the Show after their judging has been completed. The Show will close half an hour after all judging has been completed.
- 5 Entry Fees Members 1st Entry £18.00 Non Members 1st Entry £20.00 All Subsequent Entries with the same dog £1.00 per class Not For Competition £6.00 per dog. Entries may be made online at [www.onlineshowentry.com](http://www.onlineshowentry.com)
- 6 There is no prize money on offer at this Show.
- 7 The Committee reserves to itself the right to refuse entries.
- 8 Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition.
- 9 The mating of bitches within the precincts of the Show is forbidden.
- 10 Best Puppy in Show: Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and is unbeaten by any other puppy exhibited at the same show. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best in Show is a puppy it should automatically be awarded Best Puppy in Show. Where the Reserve Best in Show is a puppy which has only been beaten by an adult dog it should also automatically be Best Puppy in Show. Consequently, selection of Best Puppy in Show must follow the selection of Best in Show.
- 11 Best in Show: Best in Show must be selected from the exhibits declared Best of Sex. If a Reserve Best in Show is to be selected, the eligible dogs are those declared Best Opposite Sex and Reserve Best of Sex to the exhibit declared Best in Show.
- 12 Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with the special permission of the Show Management.
- 13 Exhibitors must not pick up dogs by their tails and leads when lifting them nor handle a dog in a manner which causes its feet not to touch the ground when on the move. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
- 14 All exhibitors must be familiar with Kennel Club Regulation F (Annex B) - Regulations for the Preparation of Dogs for Exhibition.
- 15 All dogs resident outside of the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 16 DOGS IN VEHICLES ON HOT DAYS : Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at K.C. licensed events. \* When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams. \* If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.\* The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink. \* Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around your dog. \* When at the Show, never leave your dog in the vehicle. \* Keep the dog in the shade – take your own shade, for example a large umbrella, and always have plenty of water available to drink so your dog stays well hydrated. \* Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time. Remember, if you feel hot your dog is likely to feel much hotter and dehydrated, and this could lead to dire results.

Please look after your dog's welfare. WARNING: IF YOUR DOG IS FOUND TO BE AT RISK FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.

17 Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under the Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.

18 Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered.

19 No modifications will be made to this Schedule except by permission of the Board of the Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.

20 The Committee reserves the right to appoint a substitute judge if he/she is prevented from fulfilling the engagement.

21 No animal other than those entered for exhibition or 'Not for Competition' will be allowed within the precincts of the Show.

22 All dogs must be registered or transferred at the Kennel Club before the Show.

23 The Committee will be most anxious for the care and safety of all dogs entered for exhibition and for any property entrusted to them, but it must be clearly understood by exhibitors and other persons that the Committee will not be responsible for the entire or partial loss, or detention of or damage to any dog or person from any cause whatsoever, nor for any act or omission of themselves, their officers, Servants, agents or others, and it is on this understanding only that entries are received.

24 Passes will NOT be sent.

25 The Officers and Committee can accept no responsibility for products advertised or sold by stand holders at the Show and remind exhibitors that grooming products on sale may not meet the requirements of the Regulation for the Preparation of Dogs for Exhibition F(B).

26 Any owner, competitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including car and caravan parks and approaches.

27 The owner, exhibitor, handler or other person in charge of a dog at Kennel Club licensed events must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches. This Regulation applies before (at any time during the set up period at the venue), during the event and afterwards (at any time during the breakdown of the event).

28 A dog may be disqualified by the Board from any award, whether an objection has been lodged or not, if proved amongst other things to have been: a) registered or recorded as having been bred by the scheduled Judge, this shall not apply to a Judge appointed in an emergency; b) exhibited without payment of appropriate entry fees.

29 Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.

#### **Address withheld for publication**

1. Tick the box at the bottom of the entry form near your name and address on the front of the entry form if you DO NOT want your address to appear in the catalogue. Your name will still be printed above your dog's record as normal.

2. Your address is still needed for the sending out of schedules, so you still need to enter your address in the normal way

Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the General Committee for disciplinary action under Kennel Club Rules and Regulations

## **BULL TERRIER CLUB (UK) WELFARE TRUST**

The Bull Terrier Club Welfare Trust covers the whole of the UK and is administered by the Managing Committee of the Welfare Trust. Their main objective is to look after Bull Terriers in distress and this includes help with rehousing Bull Terriers whose owners can no longer keep them and who would otherwise be put to sleep

It must be stressed that the owner should first seek help from the breeder and that together they should vigorously seek suitable new owners and homes. The Bull Terrier (UK) Welfare Trust is an emergency service and must never be used as an easy answer for any persons who should reasonably be expected to make satisfactory arrangements on their own behalf

Help is always needed with transport and/or kennel accommodation and in finding suitable homes for animals that come into the scheme. All owners can help by thinking twice before allowing their bitches to be bred from or allowing their stud dog to be used. When puppies are available they should ensure that prospective owners are carefully vetted and that they as breeders provide a lifelong "after sales" service to ensure that the dogs are cared for and enjoy good health

### **REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION**

1. These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the Board for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A11. (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat. (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A11.

2. (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the Show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the Show. (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.

3. No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:- (a) Operations certified to the satisfaction of the Board. (b) The removal of dew claws of any breed. (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated to in the opinion of the Board to deceive.

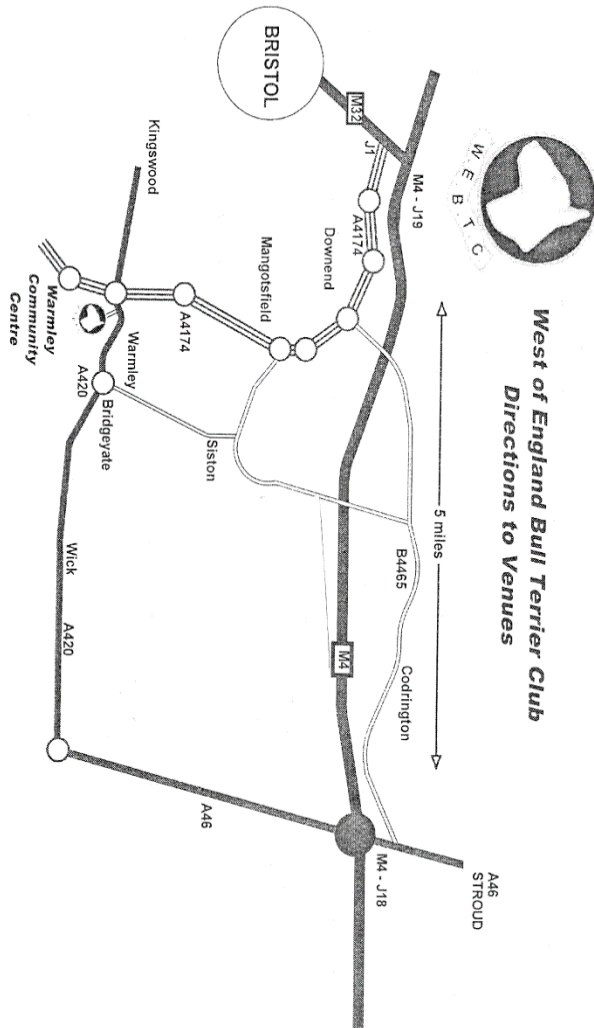
4. The Board without previous notice may order an examination of any dog or dogs at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.

5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate), to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf. 6. Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

### **COMMERCIAL PRODUCTS ON SALE FOR USE IN THE PREPARATION OF DOGS FOR EXHIBITION.**

The Kennel Club is concerned that an individual who purchases a product from a Trade Stand at a Kennel Club Licensed Show might assume, perhaps incorrectly, that the use of the product would not contravene Kennel Club Regulation f. The Committee of this Show can accept no responsibility for the products advertised or sold by stall holders at any Show, and remind exhibitors that grooming products on sale may not meet the requirements of the Regulations for the Preparation of Dogs for Exhibition.

The Officers & Committee of the West of England BTC do not accept responsibility for any product advertised or sold by Stall Holders and or Trade Stands at this Show. Exhibitors are reminded that products on sale by Trade Stands for the preparation & grooming of dogs may not meet the requirements for the Regulations for the Preparation of Dogs for Exhibition.
